

AMENDING AGREEMENT

THIS AMENDING AGREEMENT dated this 14th day of October, 2021 **BETWEEN:**

The Columbus State University Student Government Association

OF THE FIRST PART

- AND -

The Columbus State University Student Government Association By-Laws

OF THE SECOND PART

Background:

- A. The Columbus State University Student Government Association and its Executive Board have agreed with the new amendment (the "Agreement") dated October 14, 2021, for the purpose of : Requiring suspended Registered Student Organizations, following their approved appeal, to go through a probationary period following the decision of their hearing.
- B. The Executive team desires to amend the Contract on the terms and conditions set forth in this Amending Agreement (the "Agreement").
- C. This Agreement is the third amendment added to Section 3 of the By-Laws.

IN CONSIDERATION OF the Executive Board agreeing to amend their obligations in the existing Contract, and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Executive Board agrees to keep, perform, and fulfill the promises, conditions and agreements below:

Amendments

1. The Contract is amended as follows:

Page 1 of 2

Amending Agreement Page 1 of 2

- A. A hearing with an approved appeal
- B. The blueprints of a planned event and/or meeting that should consist of:
 - i. An eQuest (if applicable)
 - ii. If funding is needed, you must submit your funding request following approval to rejoin SGA to the Speaker of the Representatives
 - iii. A detailed itinerary of said event or meeting
 - iv. Date and time
 - v. Location

C. In the event that this is approved, said RSO would have to execute this event to maintain their previous good standing. This will be verified by either Speaker of the Representatives or Chief Justice and/or in other cases, any other executive board member who sees fit.

D. The probationary period will last no longer than one week. Failure to follow these procedures will invalidate your appeal regardless of approval.

No Other Change

2. Except as otherwise expressly provided in this Agreement, all of the terms and conditions of the Agreement remain unchanged and in full force and effect.

Miscellaneous Terms

3. Capitalized terms not otherwise defined in this Agreement will have the meanings ascribed to them in the By-Laws. Headings are inserted for the convenience of the Executive Board and Registered Student Organizations and are not to be considered when interpreting this Agreement. Words in the singular mean and include the plural and vice versa. No regard for gender is intended by the language in this Agreement.

Governing Law

4. Subject to the terms of the Contract, it is the intention of the Executive Board that this Agreement, and all suits and special proceedings under this Agreement, be construed in accordance with and governed, to the exclusion of the law of any other forum, by the laws of the State of Georgia, without regard to the jurisdiction in which any action or special proceeding may be instituted.


