 - **Between Sept. 29 and Nov. 18, students and employees can qualify for incentives for doing their**

part to keep themselves, their classmates, their coworkers and the community healthy.

■ **Yet-to-be Vaccinated Individuals**

- **The first 400 students and employees who receive their first vaccination on or after Sept. 29 qualify for the following - provided they show proof of their vaccination along with a completed VIP Opt-in Form (PDF)**
- **Incentive 1: First Vaccination**
 - **After their first vaccination, students and employees will receive a \$10 voucher that can be used on campus at either Chick-fil-A, Einstein's or Subway, provided by CSU's dining partner, Aramark. No change or refunds will be given for purchases less than \$10. Vouchers will be collected by the restaurant staff at the time of use.**
 - **Note: Students and employees who receive the Johnson & Johnson vaccine and elect to opt into the Vaccine Incentive Program will automatically**

receive both the first and second incentive and will be entered in the raffle.

■ **Incentive 2: Second Vaccination**

- **Students and employees receiving their second vaccination on or before Nov. 18 - and presenting proof of vaccination along with a completed VIP Opt-in Form (PDF) - can choose from one of the following:**
 - **\$100 of Cougar Cash on their 909 ID card; or**
 - **a \$100 CSU Bookstore Gift Card; or (students only) \$50 Cougar Cash and payment of or credit toward their 2021-22 parking fee; or (employees only) \$90 payment of or credit toward their 2021-22 parking fee**
 - **Students and employees on their way to being fully vaccinated (regardless of when and where vaccinated) or who are fully vaccinated by Nov. 18 can enter the VIP raffle for the following (with proof of vaccination and a completed VIP Opt-in Form (PDF)):**
 - **1st place prizes: 10 winners will have the choice of**

receiving \$500 Cougar Cash or a \$500 CSU Bookstore gift card. Students (including currently enrolled faculty and staff) also have the choice of \$500 being applied to their Bursar's Office account.

- 2nd place prizes: 20 winners will have the choice of receiving \$250 Cougar Cash or a \$250 CSU Bookstore gift card. Students (including currently enrolled faculty and staff) also have the choice of \$250 being applied to their Bursar's Office account.

- Drawing and Prize Notification: The Office of Enterprise Development will randomly select raffle winners on Nov. 19 from among those who provide proper proof of vaccination along with a completed Opt-in Form by close of business on Nov. 18. Winners will be notified by email. via email. Winners' names shall not be publicized or released.

- **New Amending Agreement**
 - **Optional for RSOs if they are out of good standing and want to regain good standing**
 - **The amendment from last forum addressed Registered Student Organizations being able to be reinstated into the Student Government Association with an approved Appeal (with signatures) and attending 2 Consecutive Forums**
 - **Even with an approved appeal, your organization will begin something called a probationary period. With another addition to the by-laws, it states that your organization must have:**
 - **-A hearing with an approved appeal**
 - **The blueprints of a planned event and/or meeting**

that should consist of:

- An eQuest (if applicable)
- If funding is needed, you must submit your funding request following approval to rejoin SGA to the Speaker of the Representatives
- A detailed itinerary of said event or meeting
- Date and time
- Location
- In the event that this is approved, said RSO would have to execute this event to maintain their previous good standing.
- This will be verified by either Speaker of the Representatives or Chief Justice and/or in other cases, any other executive board member who sees fit.
- The probationary period will last no longer than one week. Failure to follow these procedures will invalidate your appeal regardless of approval.
