Outcome of Previous Program Review

In the 2009 CPR, the review found that the program needed additional full-time faculty members to handle the increase in enrollment and course load. The department went from six full-time faculty members in 2009 to nine full-time faculty members in 2016. The Political Science Department has experienced faculty turnover and hired a new chair within the last four years. Three of the challenges noted in the last CPR were hiring faculty with terminal degrees, providing academic advising to students, and helping student with their career development. In 2015, all faculty teaching the departmental courses have terminal degrees and are engaged in creative endeavors. Through partnerships with the Advising Center (ACE), all freshmen and sophomores are advised by professional advisors, while juniors and seniors receive advising from faculty. Additionally, the department collaborates with the Center for Career Development to provide guidance on internships, careers, and job attainment.

The Departmental curriculum is strong. The political science degree is designed that students are advised to complete general education classes before they start the major. Students must satisfy Introduction to Political Science; before they can take upper level classes.

Students receive a program map that helps track and plan their classes.

Political Science student learning outcomes are evaluated in annual program review. The following outcomes are measured to improve student learning and inform program improvements.

- demonstrate knowledge of the discipline of political science in terms of its history, content, purpose and methodologies
- demonstrate knowledge of the sub-fields of political science (American politics, political theory, comparative politics, international relations, public administration, political behavior/policy, and law)
- demonstrate the ability to analyze materials (e.g. data, texts), and to think critically
- demonstrate the effective ability to communicate orally
- demonstrate the ability to communicate effectively in writing
- be prepared to achieve their personal goals with regard to intellectual and social skills
- be prepared to achieve their personal goals with regard to governmental employment, private employment, graduate and/or profession

There is a strong relationship between the program's curriculum and program outcomes. This has been evidenced through pre-and-post test scores for the American government class.

The Department of Political Science has experienced turnover in faculty and leadership including the chair position and college dean. Despite this turnover, the department continues to provide a curriculum and degree that attracts student enrollment. The program has nine faculty members who will collaborate with internal and external constituents to achieve the following seven goals.

Program Improvement Plan

1. Increase program enrollment by collaborating with Enrollment Services. This program's enrollment has decreased 33.3% over the past five years including AY 2010 (105 students) and AY 2014 (70 students).
2. Increase the number of students who graduate annually. Over the past five years, the program has graduated an average of 16 students per year. In AY 2013, 29 students graduated and in AY 2015, 12 students graduated reflecting a 59% decrease.
3. Identify "at-risk" students by utilizing EAB and collaborating with the Academic Center of Excellence to increase student retention and progression.
4. Increase faculty engagement in scholarship and research (e.g. peer-reviewed journal articles, books, monographs, etc.)
5. Increase funding opportunities for professional development by working with the Office of Sponsored Programs.
6. Implement a system that ensures full-time faculty teach a balance of lower division and upper division courses.
7. Develop a strategy for improving the quality of interactions, which was identified as a lower rate in the NSSE 2013 Survey results.
