MEMORANDUM FOR Columbus State University ROTC Cadets

SUBJECT: Columbus State University ROTC Policy for Appearance and Wear of Army Uniforms

- 1. Reference.
  - a. AR 670-1, Wear and Appearance of Army Uniforms and Insignia, 26 Jan 2021.
  - b. USACC Regulation 670-1, Uniform Wear and Appearance, 1 Feb 2020.
- 2. Purpose. To establish standards and policy for wear of Army uniforms.
- 3. All individuals must be in accordance with Army appearance and grooming standards to wear any Army uniform. This includes the Army Combat Uniforms, Army Physical Fitness Uniform, Army Service Uniform, and Army Green Service Uniform.
- 4. All Cadets who have signed a contract, receive scholarship money, or are part of the Active Duty Green to Gold program must wear the appropriate Army uniform whenever required, and must be in accordance with Army appearance and grooming standards when wearing the uniform.
- 5. Participating Cadets who are not under contract, not receiving scholarship money, and not part of the Active Duty Green to Gold program will be issued Army uniforms and must abide by Army appearance and grooming standards. If not in accordance with standards, then Cadets must wear appropriate civilian clothing when participating in ROTC events.
- 6. Cadets must wear the officer variation of the ASU/AGSU with no rank insignia or the appropriate cadet insignia. This applies to formal events, color guard, dine outs, commissioning, and any other settings where wear of the ASU/AGSU is required. Prior Service NCOs are authorized to wear the ASU/AGSU with enlisted rank insignia but must remove enlisted rank insignia before the commissioning ceremony.
- 7. Cadets may wear any authorized decorations, service medals, badges, tabs, unit insignia, unit awards, and appurtenances with the ASU/AGSU in accordance with USACC Reg 670-1 and AR 670-1. Cadets, same as officers, are discouraged from wearing marksmanship badges.
