1- Annual employment growth can be negative, while annual employment demand for the same industry/occupation is positive. This is because we may be losing jobs because of the negative domestic migration (discussed in the education attainment report and on the Butler Center Website). However, the annual demand stays positive as it considers separation from retirement and transfer to another occupation/industry.

2- The NAICS industry is divided into levels: 11 super sectors, 20 sectors (2 digits), 99 subsectors (3 digits), 311 groups (4 digits), 709 (5 digits), and 1057 (6 digits). The 20 sectors are projected to decline in Columbus, yet inside those 20 sectors, there are 4 digits, or 6 digits industries are projected to grow.

For example, the two digits sector, Health Care and Social Assistance (62) is projected to annually decline by 44 jobs; however, inside the two digits sector, there is a four digits group, Home Health Care Services (6216) is projected to add 92 jobs in the next 10 years.

3- Similarly, all occupations "major groups" are projected to decline in Columbus except information technology in the next 10 years. However, inside the 23 (2 digits major occupations) there are detailed occupations that are expected to grow. Occupations are divided into 23 major groups, 98 minor groups, 459 broad occupations, and 867 detailed occupations.

4- The annual wages in the report don't include benefits.

5- Employment counts are calculated based on place of work not place of residence.

#### **Detailed Industry Projections**

Total employment in the Columbus, GA-AL MSA is forecast to decline 6.9% over the next ten years, compared with an expected growth rate of 3.0% in the nation over the same period.

At the detailed industry level, "Individual and Family Services" and "Computer Systems Design and Related Services" are expected to experience the most job gains over this period.

### **Career Cluster Growth Forecasts**

With hundreds of occupations, it can be difficult for educators to pinpoint the most promising highdemand and high-wage occupations in their region that provide rewarding careers for their students. Analysis of the sixteen CTE Clusters provides an entryway into career pathways.

Of the sixteen career clusters, one are expected to expand employment in the Columbus, GA-AL MSA over the next ten years. Of those one, "Information Technology" pay more than the average occupation wage in the region (\$52,800).

### Career Cluster Forecasts Including Retirement Demand

Similar to the analysis of industry employment growth, an accurate assessment of future occupation demand requires that the number of people retiring be taken into account as shown in the table below. In the Columbus, GA-AL MSA, "Hospitality & Tourism," "Business, Management & Administration" and "Marketing, Sales & Service" clusters are expected to have the highest annual job demand.

"Science, Technology, Engineering & Mathematics" has the highest wages of the CTE Clusters followed by the "Information Technology" and "Finance" clusters.



#### Data Notes

- Industry employment and wages (including total regional employment and wages) are as of 2023Q3 and are based upon Bureau of Labor Statistics (BLS) QCEW data, imputed by Chmura where necessary, and supplemented by additional sources including non-covered employment such as self-employed. Employment forecasts are modeled by Chmura and are consistent with BLS national-level 10-year forecasts.
- Occupation employment is as of 2023Q3 and is based on industry employment and local staffing patterns calculated by Chmura and utilizing BLS Occupation Employment and Wage Statistics (OEWS) data. Wages by occupation are as of 2023Q3, utilizing BLS OEWS data, imputed and brought forward by Chmura. Occupation employment forecasts are modeled by Chmura and are consistent with BLS national-level 10-year forecasts.
- Job ads data are online job posts from the Real-Time Intelligence (RTI) data set, produced by Chmura and gleaned from over 40,000 websites. The data include job ads for any Zip Code Tabulation Area in or intersecting with the region for which this report was produced. Data in "Detailed Occupation Projections" reflect ads active during the 30-day period ending 03/10/2024. Data in "Top Employers Advertising for jobs" and "Top Skills in Demand for Job Ads" reflect ads active during the 12-month period ending 03/10/2024 and exclude ads from staffing companies.
- For skill and certification gaps, openings and candidates are based upon regional occupation demand (growth plus separations) and the percent of skill demand and supply. Skill demand mix data are per a one-year sample of RTI data; skill supply data are estimated using a five-year sample of resumes data; both data sets compiled as of July 2022. Data may be based, at least in part, on data from broader geographies; see the Skill Gaps analytic export for more details.
- Postsecondary are per the National Center for Education Statistics. Awards and enrollment are for the 2021-2022 academic year and average net price data are for the 2020-2021 academic year.
- Figures may not sum due to rounding.

#### How are industries and occupations defined?

Industries are defined via the North American Industry Classification System (NAICS). "Sectors" in this report represent 2-digit NAICS codes and industries in the "Industry Analysis" section of this report represent 4-digit NAICS codes. Occupations are defined via the Standard Occupational Classification System (SOC). Occupations in the "Occupation Analysis" section of this report represent 6-digit SOC codes. "CTE Clusters" are collections of 6-digit SOC occupations as defined through the National Career Clusters® Framework.

#### How is "Ann Total Demand" defined?

Annual total employment demand is forecast job demand that includes job needs due to growth, exits (such as retirements), and transfers (individuals moving from one career into another).

#### What is the Living Wage used in this report?

The living wage in the United States is \$25.02 per hour in 2022, before taxes for a family of four (two working adults, two children) - MIT Living Wage Calculator.
